





# **Colorado Battleground Swing State has Swung**

"The recent decade of Republican dominance peaked in 2002 when the party saw Gov. Bill Owens re-elected with 63 percent of the vote, Wayne Allard won re-election to U.S. Senate (joining Republican Ben Campbell), a win of Colorado's new 7<sup>th</sup> congressional seat, and continued control of the state legislature.

A mere six years later, Democrats now have the governorship, both U.S. Senate seats, both houses of the state legislature, and five of the seven congressional seats. With the help of Barack Obama's ground force, Democrats erased a 170,000 Republican voter registration advantage and are now dead even. ### **Colorado's Shift Foretells National Trend**

- Gary Hart: Manifesto: Democrats and the West, Fall 2006
- Fred Barnes: The Colorado Model, Weekly Standard, 7/21/08
- Ryan Lizza: The Code of the West, New Yorker, 8/22/08
- Agenda Shift: Colorado economic downturn shifts agenda to left and away from social issues, limited government spending and tax cuts.
- Democrats and \$: Growth of Democratic bench and support infrastructure (money, think tanks, blogs). Candidates position in the middle (Salazar/Ritter).
- New Voters: Rapid growth of new voters in suburbs, exurbs and I-70 corridor. Split tickets and register more independent, Hispanic and young voters. Republicans lose registration edge (1,060 Republicans, 1,061 Unaffiliated, 1,046 Democrats).
- Internal Division: Colorado Republicans divided on fiscal and social issues (Referendum C). Good vote-getters leave office. Face tough primaries.
- > Brand Collapse: National Republican fortunes decline.


### **Senate Seat Switches Udall Wins 52.8% to 42.5%**



- Unaffiliated voters less ideological and more pragmatic, avoid labels, vote for person, fiscal responsibility, socially moderate, cautious on security.
- Udall wins unaffiliated voters, including some conservatives



#### **Unaffiliated Voters Support Udall Across Ideology**




# True to Principles or Find Solutions Move to Right or Get to Center




- Voters 29% liberal, 25% middle, 41% conservative



#### **Floyd Ciruli**

"The governor continues to be popular with most Coloradans. A September survey by Denver pollster Floyd Ciruli showed Ritter with a 57 percent favorable rating and a 28 percent negative rating. On the average voter level, Ritter is not in all that bad a shape, Ciruli said. I think his problem is with the 'attentive public,' and that includes his own party. If you're talking to anyone out there in the political world, there's this sense that he's made some serious political mistakes and also not been able to deliver on some substantial promises." ### **Polls, Elections and Schools**

#### Mesa

- Pro school vote closely divided
- Education is important vs. wastes money/taxes too high

#### Denver

- Don't know school board incumbents 63%
- Don't support special interest takeover
- 53% favor school closures

#### State

- Less trust in state government, more partisanship
- School support stronger locally than statewide
- Presumption of constitutional status quo

### Fiscal Crises and Stimulus Package Elections Have Consequences

## District to trim 300 jobs; \$35.7 million in next two years.

- 238 jobs cut; mil levy failed
- Cuts before state fund reductions
  - CS District 11
  - Douglas
  - Jefferson
  - Mesa
  - Pueblo 60

#### Stimulus package won't save 2009

- Amount uncertain and arrives late
- Money for Title I, special education, buildings, stabilization
- State funds cut
- Next year could be as bad or worse

## We're Going to Need a Bigger Boat

- \$787 billion stimulus
  - \$280 billion tax cut
  - \$89 billion Medicaid for states
  - \$39 billion transportation (highways/bridges transit)
  - \$44 billion education, school repairs
  - \$21 billion health technology
- Colorado stimulus
  - \$1.97 billion
  - 60,000 jobs
  - \$404 million transportation
- \$700 billion TARP (Troubled Asset Relief Program)

Weak support for bailout

59% favor spending

### **New Administration's First Four Weeks**

#### Accomplishing goals

- 1. But no bipartisanship
  - Economy/stimulus package takes more time, thrown on the defensive, no Republican support, bailout launch weak
- 2. Transition, very studied, not Clinton (Bill)
  - Experience experts, bi-partisan, center to center-left
  - But, confirmation problems: Blagojevich/Richardson/Geithner/Daschle
- 3. Start quickly
  - Stay on big issues, but imbed Democratic solutions, such as spending on infrastructure, renewable energy
  - Go into campaign mode, get out of DC into states
- 4. Controversy
  - Left on Guantanamo, torture...
  - Employee free choice act (28% very important)/Justice Department crimes
- 5. Keep focus on 2010 mid-term and 2012 reelection: realignment or just bad year?
  - Colorado remains a battleground
